Benefits to Students/Parents

- No need to visit the Institute only for fee payment.
- Outstation Students / Parents can pay from their home town itself.
- Choice of location for payment of fees from any of ICICI Bank Branches in India
- No Need to Carry the Cash with you for paying the Fees.

The Fee Payment can be done in any of the following ways.

• By deposit of Cash at any of the ICICI Bank branches across the country.

By downloading the pre-designed Challan from the college website www.pydah.edu.in in the quick link, the student/Parent can directly visit the nearest bank and fill the concern student details and pay the desired amount at the cash counter of the bank by collecting the dual receipt for the same.

The challan consist of three copies (Bank Copy + Institution copy + Student copy), out of which the institution copy is to be submitted by the student later.

Note: For every transaction, bank charges the mandatory fee of Rs.10/- from the student/Parent directly for using the above facility.

E-PAYMENT (RTGS / NEFT) FACILITY *

We facilitate access of our institution students to Retail Electronic Payment Platform viz. RTGS / NEFT network. This would help students/parents to deposit the fee to institution's accounts through RTGS / NEFT mechanism, facilitating access from more than 75000+ bank branches of RTGS/NEFT member banks in India.

The Student/ Parent for paying the fees to college account would be required to use 4 digit code followed by PIN number / Admission number as beneficiary account number.

• CARD - PAYMENT FACILITY:

We Facilitate the Student's/Parent with access of swiping the Debit Card issued by any legal bank for paying the College fees. This facility is only available at Engg college office where any stream/Branch Student can visit the office for using the facility.

Note: Processing charges will be levied by the bankers upon the amount of transaction made by the student/Parent. Kindly go through the charges sheet before the payment of the same.
